INTEREST RATES AND INTEREST CHARGES	
Annual Percentage Rate (APR) for Purchases	2.99% on transactions done in the first twelve months after account was opened. After that, your APR will be: 10.74% to 20.74% , based on your creditworthiness. The APR will vary with the market based on WSJ Prime Rate.
APR for Balance Transfers	On transfers done during the promotional period* 1.99% to 16.99% for 12 months from the date of transfer, based on your creditworthiness. After that, your APR will be: 10.74% to 20.74% based on your creditworthiness. The APRs will vary with the market based on WSJ Prime Rate.
APR for Cash Advances	10.74% to 20.74% when you open your account, based on your creditworthiness. After that, your APR will vary with the market based on WSJ Prime Rate.
How to Avoid Paying Interest on Purchases	Your due date is at least 25 days after the close of each billing cycle. We will not charge you any interest on purchases if you pay your entire balance by the due date each month.
